THE GRAND JURORS of the State of Tennessee, duly selected, empaneled, sworn and charged to inquire for the body of the county of Shelby, Tennessee, upon their oath, present that:

on November 10, 2023 in Shelby County, Tennessee, and before the finding of this indictment, did unlawfully attempt to commit the offense of First Degree Murder, as defined in T.C.A. 39-13-202, in that he did unlawfully, intentionally, and with premeditation attempt to kill KEVIN HAYES, resulting in serious bodily injury to the said KEVIN HAYES, in violation of T.C.A. 39-12-101, against the peace and dignity of the State of Tennessee.

#### Count 2

THE GRAND JURORS of the State of Tennessee, duly selected, empaneled, sworn and charged to inquire for the body of the county of Shelby, Tennessee, upon their oath, present that:

### **COURDARIAN CRAFT**

on November 10, 2023 in Shelby County, Tennessee, and before the finding of this indictment, did unlawfully attempt to commit the offense of Especially Aggravated Robbery, as defined in T.C.A. 39-13-403, in that COURDARIAN D CRAFT did unlawfully, intentionally or knowingly, attempt to take from the person of KEVIN HAYES certain property, to wit: shoes, of the value of \$1,000 or less, by violence or by putting KEVIN HAYES in fear, by use of a deadly weapon, and KEVIN HAYES suffered serious bodily injury, in violation of T.C.A. 39-12-101, against the peace and dignity of the State of Tennessee.
